1. The vendor shall submit Xerox copy of valid Trade License, VAT Registration no.
2. Vendor should attach leaflet with quotation if available.

4. The terms and conditions of quotation is to be enclosed in one envelop and pricelist is to be enclosed in other envelop. Both the envelop is to be placed in another envelop and sealed.
5. Validity:

The offer will be for **one month** from the date of issue of the order.

6. DELIVERY / COMPLETION:-
 - a) Delivery of the materials should be made within **one month** from the issue of the order
 - b) F. O. R. Destination


7. PAYMENT:

- a) Three copies of challan & bills should be submitted to process the bill.
- b) Payment will be made within 30 days of receipt of materials at site or receipt of bills/completion of work/ service rendered, whichever is later.
- c) The supplier /contractor shall submit all bills on the printed form in their own pad with the photocopy of work orders.
- d) 10% of every bill amount shall be retained by authority on account of security deposit, if necessary.

The security deposit will be paid without any interest subject to adjustment of any dues after completion of the warranty period from the date of supply.

- e) If any defect is detected within the warranty period, the supplier / contractor shall rectify the defect free of cost within a reasonable time. If the contractor/supplier failed to rectify the defect, the authority shall have the right to forfeit full or part of the security deposit.
- f) The liquidated damage will be imposed @ for each week.
